### **Consideration of Investment Project**

1. The Board of Directors considered the Memorandum and Recommendation of the President and approved the proposed Tajikistan Rogun Hydropower Development Program (Project Number 000687) as recommended and as follows: (i) Approval of the Program with an entire envelope of USD500 million of sovereign-backed financing to Tajikistan; (ii) Approval of the commitment of Phase 1 Loan of RMB1,922.20 million (equivalent to USD270 million); and (iii) Authorization to the President to approve the commitment of Phase 2 financing of USD230 million.
