1. The Ministry of Public Works and Transport has received financing from the Asian Infrastructure Investment Bank (AIIB) toward the cost of the Preparation of Urban Infrastructure Development Project (PPSF project) and intends to apply part of the proceeds for consulting services.
2. The Ministry of Public Works and Transport now invites qualified and experienced Consulting Firm to indicate their interest in providing the Service. The consulting firm will be selected in accordance with the AIIB's Procurement Policy (June 26, 2024, as amended from time to time) and Directive on Procurement Instructions for Recipients (July 26, 2024, as amended from time to time) and Royal Government of Cambodia's Standard Operating Procedures.
3. Interested Consulting Firm should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The selecting criteria are: (i) The Consultant or lead firm in the case of joint venture, shall provide at least 3 (three) documented relevant references of experience of Projects with similar scope of services, over the previous 10 (ten) years of operation. (ii) The Consulting firm, or lead firm in the case of a joint venture, shall have a minimum of 15 years of experience in providing infrastructure engineering consulting services, of which at least ten (10) years of experience shall be in the water & sanitation sector or urban development sector with experience of working on projects with similar scope of work – preparation of FSR, ESIA and developing detailed engineering designs & drawings. (iii) The Consulting Firm or every individual member in case of a joint venture shall have completed with Client's acceptance of deliverables, at least two similar assignments (FSR and/or Detailed Engineering Design or ESIA) on multilateral or bilateral donor financed projects in the last 10 years. (iv) The Consulting Firm or lead firm in case of a joint venture shall have

experience of working on at least one completed assignment in the water or sanitation sector in the last ten years in Cambodia or in any country in Asia.

4. Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
5. A Consulting Firm will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Directive on Procurement Instructions for Recipients.
6. The duration of the contract is 18 Months.
