3. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The selecting criteria are: (i) At least bachelor's degree in business administration, Commerce, Law, Engineering, or a closely related field. (ii) Minimum of 8 years of relevant experience in procuring goods, works, and consulting services for projects funded by bilateral/multilateral organizations like AIIB, WB, ADB, EU, and other development donors. (iii) Minimum of 5 years of experience with the Royal Government of Cambodia's Standard Operating Procedures for Implementing All Externally Financed Projects/Programs is a strong advantage. (iv) Ability to work independently and provide training to others as needed. (v) Excellent communication and collaboration skills, with the ability to work effectively as part of a team. (vi) Fluency in written and spoken English and Khmer, with strong report writing skills.
