- The Government of Lao PDR has received financing from the Asian Infrastructure Investment Bank (AIIB or the Bank) toward the cost of the Climate Resilience Improvement of National Road 13 South Project (Section 3), and intends to apply part of the proceeds toward payments under the contract for Construction of 4 New Bridges along NR13 South in Bolikhamxay Province.
- The Ministry of Public Works and Transport of Lao PDR now invites sealed Tenders from eligible Tenderers for construction of 4 new bridges along NR13 South in Bolikhamxay Province. The Works include the bridge construction with Reinforced Concrete, Prestressed Concrete types of structures, as well as the road access works which involve earthworks, drainage, slope stabilization, pavement and road furniture works. The works are to be completed in conformance with the technical specifications and expected to be carried out over a period of 18 months followed by a 1-year defect liability period. The Department of Roads (DOR) of the Ministry of Public Works and Transport (MPWT) will be the lead implementing agency for this sub-component. Main site or place of performance:

The complete set of Tender Document English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of USD 150 or equivalent in Lao KIP. The method of payment will be cash or cashier's cheque. The document will be sent by e-mail or airmail for overseas delivery, at the bidder's preference, and by surface mail or courier for local delivery. 6. Tenders must be delivered to the address below on or before **24 January 2025, 14:00** hours local Lao PDR time. Electronic bidding will not be permitted. Late Bids will be rejected. The outer Bid envelopes marked "ORIGINAL BID", and the inner envelopes marked "TECHNICAL PART" will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend, at the address below on **24 January 2025, 14:30** hours local Lao PDR time. All envelopes marked "FINANCIAL PART" shall remain unopened and will be held in the safe custody of the Employer until the second public Bid opening.
7. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document
8. All Tenders must be accompanied by a **Tender Security of 80.000 USD** or equivalent amount in a freely convertible currency or in Lao Kip (LAK).
