The Republic of the Philippines has received/applied for financing from the Asian Development Bank (ADB) in joint co-financing with the Asian Infrastructure Investment Bank (AIIB) towards the cost of **Laguna Lakeshore Road Network (LLRN) Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from all countries with exceptions specified in the Bidding Documents.

2. The **Department of Public Works and Highways** (“the Employer”) invites sealed bids from eligible Bidders for the construction and completion of **Contract Package 2, San Pedro/Biñan – Cabuyao Section, Stage 2, Laguna Lakeshore Road Network (LLRN) Project – Phase I** (the “Works”).

A complete set of the Bidding Documents may be acquired by the eligible bidders from **8 October 2024 to 26 November 2024** from the DPWH Procurement Service (PrS), 5th Floor, DPWH Bldg., Bonifacio Drive, Port Area, Manila, and upon payment to the DPWH Cashier a nonrefundable fee of **Seventy-Five Thousand Pesos (PHP 75,000.00)** in cash payment/ cheque payment/ pay order/ demand draft not later than the deadline for submission of bids. The bidding document may be sent by courier for an additional fee of **Php 5,000.00 (USD 100.00)** for domestic delivery. No liability will be accepted for loss or late delivery.

The Bidder's representative must present a letter duly signed by the Authorized Signatory of the firm, authorizing him/her to acquire the Bidding Documents.

The bidding documents may also be downloaded from the websites of the **Philippine Government Electronic Procurement System (PhilGEPS)** (<http://www.philgeps.gov.ph>) and **DPWH** (<http://dpwh.gov.ph>), provided that the bidders shall pay the applicable fees upon the submission of their bids.

The Bidding Documents for **Contract Package 1, Alabang – San Pedro/Biñan Section, Stage 2, Laguna Lakeshore Road Network (LLRN) Project – Phase I; Contract Package 2, San Pedro/Biñan – Cabuyao Section, Stage 2, Laguna Lakeshore Road Network (LLRN) Project – Phase I** and **Contract Package 3, Cabuyao – Calamba Section, Stage 2, Laguna Lakeshore Road Network (LLRN) Project – Phase I**<sup>2</sup> have been prepared separately but will be bid out concurrently. Bidders may bid for a single package only or for multiple packages. In case the bidder wishes to submit bids for multiple packages, such bids shall be submitted independently and not combined into a single bid. Details about evaluation procedures are provided in the Bidding Documents.

The Employer reserves the right to reject any and all bids, to annul the bidding process or declare a failure of bidding, or not award the contract at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders. In case of annulment, all Bids submitted and specifically, bid securities, shall be promptly returned to the Bidders.
