2. Project Summary and Objectives

The objective of the Project is to support the Government of Bangladesh (GoB) to prevent, detect, and respond to the threat posed by COVID-19 and to strengthen its national systems for public health preparedness in Bangladesh. This Project is supported under the COVID-19 Crisis Recovery Facility (the Facility) of the Bank and co-financed with the World Bank (WB) as an investment project. The Project will help the GoB respond to immediate health consequences of the COVID-19 pandemic and strengthen health systems for pandemic preparedness. In addition to scaling up interventions to limit human-to-human transmission, health systems strengthening interventions will be rolled out to improve the country's capacity to respond to the COVID-19 epidemic and to be better prepared to respond to any future disease outbreaks. The Project includes the following components:

- Component 1: Emergency COVID-19 Response. This will provide immediate support to Bangladesh to prevent COVID-19 from arriving or limiting local transmission through containment strategies.



- Component 2: Supporting National and Sub-national Prevention and Preparedness. This will include activities which aim to improve prevention and response planning for infectious disease.
- Component 3: Implementation Management and Monitoring and Evaluation. This will include the areas of project management, monitoring and evaluation, fiduciary, and environmental and social safeguards.
- Component 4: Contingent Emergency Response Component. This will ensure provision of immediate response to an Eligible Crisis or Health Emergency.

5. Project Implementation Update

The legal agreement was signed, and the project loan became effective on April 12, 2021. The project is supporting implementation of the priorities identified in the MoHFW's National Preparedness and Response Plan for COVID-19. A Project Implementation Unit (PIU) with required staffing has been set-up at the Directorate General of Health Services (DGHS). The GoB has established a Project Steering Committee led by Secretary of the Health Services Division of the MoHFW, and a Project Implementation Committee led by Director General of DGHS.

Financial Management:

The PIU has in place a Junior FM Specialist and a Senior FM specialist to carry out the financial management activities. The PIU is maintaining the books of records manually and financial reports are prepared using excel spreadsheets. The PIU is submitting the interim unaudited financial reports (IUFRs) in a timely manner. The next round of IUFRs, for the June 2022 semester, will be due on August 15, 2022.

The audit report for FY 20 and FY 21 which became due on December 31, 2021 is approximately 6 months overdue. There are delays in resolving the FY20 and FY21 audit observations raised by the Foreign Aided Project Audit Directorate (FAPAD). In July 2022, DGHS, Financial Management and Audit Unit (FMAU) of the MoHFW and the World Bank discussed and agreed on a way forward so adequate clarification/response is provided to FAPAD on the audit observations and reduce the time lag for sending responses to FAPAD. The next annual external audit report of FAPAD for FY22 is expected to be submitted to the World Bank & AIIB for review on or before December 31, 2022.

6. Status of the Grievance Redress Mechanism (GRM)

An existing functional GRM of the MoHFW is being used effectively for all health-related services including those related to COVID-19. The information of the GRM has been disseminated in the Stakeholder Engagement Plan.
